

Last Version



The last version of the FFIEC IT Examination Handbook was issued in 1996 and included two extensive volumes of over seven hundred pages. An interagency working group, composed of representatives from each of the FFIEC's five member agencies, developed that version, and

the same is true for the revision currently under development. The active working group is composed of members from:

- The Board of Governors of the Federal Reserve System (FRB),
- The Federal Deposit Insurance Corporation (FDIC),
- The National Credit Union Administration (NCUA),
- The Office of the Comptroller of the Currency (OCC), and
- The Office of Thrift Supervision (OTS).

Within this working group, one agency assumes responsibility for an IT topic and develops the first draft of material relating to that topic, including a comprehensive narrative and, in most cases, a related workprogram.

The drafts then undergo an extensive series of reviews by the working group, related FFIEC committees and subcommittees, and other groups within each agency.

When ready, the documents are reviewed or tested by field examiners from all five agencies and revised, if necessary, based on examiner feedback.

Finally, there is senior management review and approval in each agency and the documents are formally released.

Volume Challenge



Considering the volume of information in the handbook, this development and review process is monumental, and keeping the handbook current is no small task.

In order to address this challenge, the FFIEC agencies have redesigned the process for releasing revisions to the handbook.

The current revision cycle involves releasing a series of topical booklets, rather than one handbook. This approach will allow future updates to be made in smaller—more manageable—segments of information.

Thus, the 1996 IS Handbook is being replaced, one section at a time, with a release of a series of IT Handbook Booklets issued over the period of months. Each booklet will be released as it is completed, and it will be updated as a stand-alone document, as changes in IT technology and the evolution of standards related to financial institution IT practices necessitate.

The nature of the topic will determine its length, but generally each booklet will include:

- Workprograms,
- Action summaries,
- A Glossary, and
- A list related laws, regulations, and guidance.

Although the booklets are intended for use by a wide range of audiences, the content is written at a level appropriate for a midlevel IT examiner. Examiners will target the workprogram procedures based on the risk in specific examination environments.
